- Must provide evidence of liability and workers compensation insurance prior to executing a contract leasing the space.
- All employees of the salon must meet all requirements as promulgated by the state of New Jersey.
- 4. The selected vendor must maintain obtain all necessary permits and operate according to all Department of Health and other applicable regulatory agencies.
- 5. Must provide phone service for residents to book their appointments.
- Should be open at times that are convenient to senior citizens.

Qualifications:

 Must have possess necessary license(s) for operating a hair salon.

2) Must be approvable by the United States Department of Housing and Urban Development.

3) Must provide evidence of adequate liability & workers compensation insurance prior to execution of the lease.
