# RESOLUTION #2023-27, Authorization to Solicit Bids to Replace Common Area Flooring

WHEREAS, the Newton Housing Authority has need to replace the flooring in the corridors, Community Room, and common areas at Liberty Towers; and

WHEREAS, the U. S. Department of Housing & Urban Development provides annual funding to make capital improvements at Liberty Towers through the Capital Fund Program (CFP); and

WHEREAS, the Housing Authority's Procurement Policy requires that the Authority obtain bids & proposals for all goods & services; and

WHEREAS, the Housing Authority desires to make building improvements that would improve the quality of life for its residents; and

WHEREAS, the purchase of the flooring would require that public bidding documents be prepared by the Executive Director and a formal solicitation for bids be authorized by the Board of Commissioners; NOW THEREFORE

**BE IT RESOLVED** by the Board of Commissioners of the Newton Housing Authority that the Executive Director is authorized to prepare bidding documents and solicit for public bids to replace the flooring at Liberty Towers.
