ADMINISTRATIVE REPORT - EXECUTIVE DIRECTOR SNYDER

- 1. All RFPs went out previously and contracts being awarded this evening. (Resolutions #2023-38 through #2023-42.)
- 2. All policies of Newton Housing Authority will be uploaded Admission Continued Occupancy Policy will be one of the first as HUD has made changes.
- 3. Vacancles There are currently 5 vacancies 2 units are ready; 1 is in very bad shape and needs flooring; 1 needs kitchen cabinets. Ed is working on that. Karen is calling people now regarding 2 available units.
- 4. After painting was completed, residents requested hooks be reinstalled on doors for hanging wreaths, etc. Ed has completed that where people requested them.
- 5. Notice issued to everyone regarding bulk items; should not be placed in hallway as it's a Fire Code Violation. If the tenant needs if removed, Office has name of someone who has agreed to take it out at a very reasonable price.
- 6. Air Handler The new free stack that was installed is now working properly. Ed changed all 12 air filters as air handler is now running. The air handler was turned on in the corridors, which pressurizes the corridors. Resident complained that mold was coming out of registers on the floors; very aggravated about it. I checked it out, not mold but just dust/dirt accumulating. Tenant threatened to go to Health Department. Because of that, we took off all the registers; they were cleaned, put back on. Stanley Steamer is coming in and going to clean the make-up air shaft all the way to Ist floor, which should take care of that.
- 7. Elevator Clutch will cost \$8,100 to replace it. Parts are on order. Elevator in-service, we hope it doesn't go out.
- 8. No roof leaks at the present time. Ed and I have inspected it before ice/snow happens. There is ponding on roof, but looks to me like there was tapered installation, but not flowing to the drains. When we do new roof, we will make sure it's properly tapered so water drains. Water on a rubber roof when it freezes can cut right through rubber.
- 10. Kick-off Meeting with Architect Architect was selected last month to do roof and airconditioners. They'll come back to us, bring it to the Buildings & Grounds Committee with some ideas on how to that. Architect here half a day looking at roof, which is relatively simple to replace as not a lot of protrusions through it. They took measurements; we gave them drawings. They also took a look at the compactor when they were here. Our compactor has not been working for years, and they'll see if anything can be done with that so #1, it doesn't smell, no odors. #2 it will work so tenants can use it instead of

walking to back of property. Details and logistics are not worked out yet. They're trying to find a P-Tack unit. Dimensions or all the ones I looked at were slightly bigger than that opening in the window. They're going to do calculations and give us an idea, possibly cutting through the block.

(At this point, Commissioner Vandermaas came into the meeting – 5:30 P.M.)

Commissioner Carlson asked about recycling bin? ED SNYDER: Usually, it's put in pails and taken out.

- 11. **Jockey Pump** that's leaking in back room is still leaking. We're told it's anywhere from 6 weeks to 3 months to get the parts. There is some rust and water on the floor.
- 12. **Exterminator Schedule** being prepared; residents are notified, and tech comes monthly. Notice will be posted for upcoming month as to when to expect them.
- 13. Group of tenants got together and put up decorations throughout the building. It looks very festive.
- 14. **Resident Association** having a Holiday Party coming up on December 20th at noon. Board Members are also invited.
- 15. **Tenant Gary Renaldi** who has antique Lionel trains; he set trains up in Arts & Craft Room, He will set the trains up for tenants to see between December 18th-January 15th.
- 16. Sussex County Community College Culinary Institute is having its Senior Citizen Lunch on December 14th. Many of NHA residents have signed up for it.
- 17. Sussex County Health Department is coming on December 15th to sign people up who need PAAD pharmaceutical program at 10 A.M. If you need help they'll be here. Income limits are \$52,000 for individual; \$59,000 for a couple.
- 18. Sussex County also coming on January 26th, February 9th and March 1st. They will do a Blood Pressure Clinic, heart screening and a nutritional presentation. Karen is going to prepare a slide or put it on the bulletin board and get to all residents.

OLD BUSINESS

Vice-Chairman Bitondo noted need to update NHA website as agendas, minutes and audits are behind schedule in being posted. Agendas should be posted prior to a meeting being held, so NHA delinquent with that.

NEW BUSINESS

Vice-Chairman Bifondo said Chairman Fiedorczyk was retiring and Commissioners had discussed an award for Maria. Commissioner Crossley suggested inviting her family and Kevin to the January meeting to present posthumously a crystal obelisk. Commissioner Ricciardo will speak a bit on his friendship with Maria for over 40 years, when he ran for Council with her brother, noting how hard she worked on their campaign; truly a great, caring woman. V/C Bitondo and Commissioner Ricciardo will work on presentation. ED Snyder will reach out to her family members and Town Manager Tom Russo. NHA meeting will be Monday, January 22, 2024. Commissioner Crossley will take care of refreshments.

V/C Bitondo asked for FY-2023 financial report for January 22nd meeting or February, so report will be complete. ED Snyder has asked accountant for quarterly report one month after quarter ends.

V/C Bitondo asked ED Snyder if it's possible to get notice from Gerber perhaps an hour ahead of them coming. ED Snyder will reach out to Gerber to ask about it.

V/C Bitondo asked if an addendum could be added to snow removal contract; if Gerber has a small snow blower that could go between the cars. Commissioner Ricciardo: Because of space between cars, it is not possible to get a snow blower between them.

LOUIS – #2E – Works part-time for emergency maintenance here; cleaned out ducts but dust really stuck to ducts. ED Snyder said Stanley Steamer was here today and they can clean them.

KATHLEEN - #2L – An apartment has been empty since September, it is still vacant and has been updated, why isn't it rented? ED Snyder: Some people turned it down. 96 might be waiting, but that doesn't mean they'll say yes. We are in process of doing it now.

MARY - #3D - Very pleased with prices here; visitors like the building and think it's very cheerful and comforting. Thank you very much.

V/C Bitondo sent photos to ED Snyder and Chairperson Fiedorczyk of John Jay Building in Dover. It is dear to him as his wife's grandmother was resident there; wife's mother was a Commissioner. The building is beautiful and looks very stately, well maintained and landscaped. We here are working towards that.
