REQUEST FOR BIDS

The Newton Housing Authority, 32 Liberty Street, Newton, New Jersey will accept bids for replacement of flooring in apartments for a two-year period (1/1/26-12/31/27). It is the Housing Authority's desire to retain and employ a duly qualified and capable contractor. All services must be in accordance with the existing laws, rules, orders, directives, and regulations governing these services.

The services that are requested will be as follows and will encompass Liberty Towers (80-unit elderly high-rise property:

- 1) The contractor will be required to furnish all labor and materials necessary to professionally replace the flooring in units as specified by the Housing Authority at turnover (upon tenants moving out of the building).
- 2) The contractor will be required to prepare all the floors, remove existing carpet, remove, and replace all vinyl cove base and replace carpet with the specified flooring. This shall include leveling and removal of all debris.
- 3) Protect other surfaces, items, or materials against damage from installation of flooring (cabinets, fixtures, counters, light fixtures, etc.
- 4) Flooring Specification-equal to "TrafficMaster-GripStrip Flooring, 25-year warranty, 6" by 36" planks, oak color (Home Depot). The contractor may substitute an equal product with the approval of the Housing Authority.

5) The contractor shall be required to replace flooring in each unit within 72 hours of being notified by the HHA office

- staff. All work must be performed between the hours of 8:00 AM to 6:00PM-Monday to Friday.
- 6) The contractor will be required to remove all related debris at the conclusion of each workday. Do not discard in the Housing Authority's dumpster.
- 7) The contractor shall replace flooring in other areas as directed by the owner. The price shall be based upon an hourly labor rate, plus the cost of materials.
- 8) Payment shall be made upon the inspection and acceptance of the work by the maintenance supervisor.

Qualifications:

- 1) Should be in the flooring business a minimum of three years.
- 2) Must be approvable by the U.S. Department of Housing and Urban Development to provide these services.

Bid Submission:

All persons interested in submitting a bid for the Housing Authority's flooring replacement of turnover units should submit a price based upon the type of unit: (0-Studio and 1-bedroom units). The unit prices will include all labor and materials. The proposal must include the following:

- 1) Cost based upon the unit size.
- 2) An itemization of other expenses (be specific).
- 3) Bid Submission Form.
- 4) Copy of the vendor's insurance certificate (including workers comp.)
 - 5) Listing of references.
 - 6) Copy of your NJ Business registration form.
 - 7) Non-Collusion Affidavit
 - 8) Federal non-debarment form
- 9) Manufacturer's specification sheet indicating the proposed flooring to be utilized.

Bids should be delivered to the Newton Housing Authority, 32 Liberty Street, Secaucus, New Jersey on or before October 8th, 2025, by 10:00 AM. The buildings are available for inspection between the hours of 8:30 AM to 4:00 PM, Monday to Friday.

The Housing Authority reserves the right to reject any and all bids received for these services. It also reserves the right to terminate the vendor, for convenience, at any time during the term of the contract. The Authority may choose to utilize the New Jersey Cooperative Purchasing Program, at any time during the contract, if their prices are lower than the selected vendor.

The selected flooring contractor will be paid within 45 days of completion of a unit. No payment will be made until the Authority's maintenance supervisor has inspected and approved the completed unit.

This solicitation for bids is being made in accordance with the New Jersey Local Unit Pay to Play law (NJSA 19:44A 20.4 et seq.) as a "fair and open" process. All proposals will be publicly opened on the date and time specified in the RFB.
