The Housing Authority of the Town of Newton, New Jersey will accept proposals for maintenance of its computer hardware and software. It is the Housing Authority's desire to retain and employ a duly qualified computer specialist who is experienced in maintaining a small office computer system. All services must be in accordance with the existing rules, orders, directives, and regulations promulgated by the United States Department of Housing and Urban Development, local and state laws governing this work.

The services that are requested will be as follows:

- 1) Maintain and troubleshoot all hardware problems. Recommend all upgrades to the existing system.
- 2) Maintain and troubleshoot all software related problems.
- 3) Maintain and troubleshoot all operating system and network related problems.
- 4) Install all software as recommended by the Housing Authority (including PHAweb software upgrades).
- 5) Respond to all emergencies within 3 hours.
- 6) Provide all services and equipment necessary to ensure that the Authority's computer system is operating efficiently and effectively.
- 7) Other computer services as directed by the Housing Authority.
- 8) Ensure that all systems are adequately backed-up to ensure that no data is lost in the event of a system failure.

Qualifications:

1) Must be a duly qualified and authorized to provide all Microsoft and Novell Netware services.

2) Must have demonstrated experience in performing the required services.

3) Must have a minimum of 5 years' experience.

3) Must be approvable by the United States Department of Housing and Urban Development.

All persons interested in submitting a proposal for the computer services should submit a proposal based upon an hourly rate.
