REQUEST FOR BIDS

The Newton Housing Authority, 32 Liberty Street, Newton, New Jersey will accept bids for waste and recycling containers. It is the Housing Authority's desire to retain and employ a duly qualified and capable carting company. Services shall be provided for an 80-unit, elderly, high-rise project in Newton, NJ. All services must be in accordance with the existing laws, rules, orders, directives, and regulations governing these services.

The services that are requested will be as follows and will encompass the Liberty Towers property (32 Liberty Street, Newton, NJ):

- 1) Provide a 6-yard FEL container for building waste. The container must be emptied twice (2) weekly on the same days (Monday & Thursday).
- 2) Provide a 6-yard FEL container for building recycling.

 The recycling container must be emptied once (1) weekly on the same day (Tuesday).
- 3) The vendor is responsible for the maintenance and repair of the containers due to normal wear and tear.
- 4) Other services as requested by the owner.
- 5) Payment shall be made monthly based upon the itemized service provided.
- 6) The term of the contract shall be two (2) years (1/1/26-12/31/28)

Qualifications:

- 1) Should be in the waste removal business a minimum of three years.
- 2) Must be approvable by the U.S. Department of Housing and Urban Development to provide these services.
